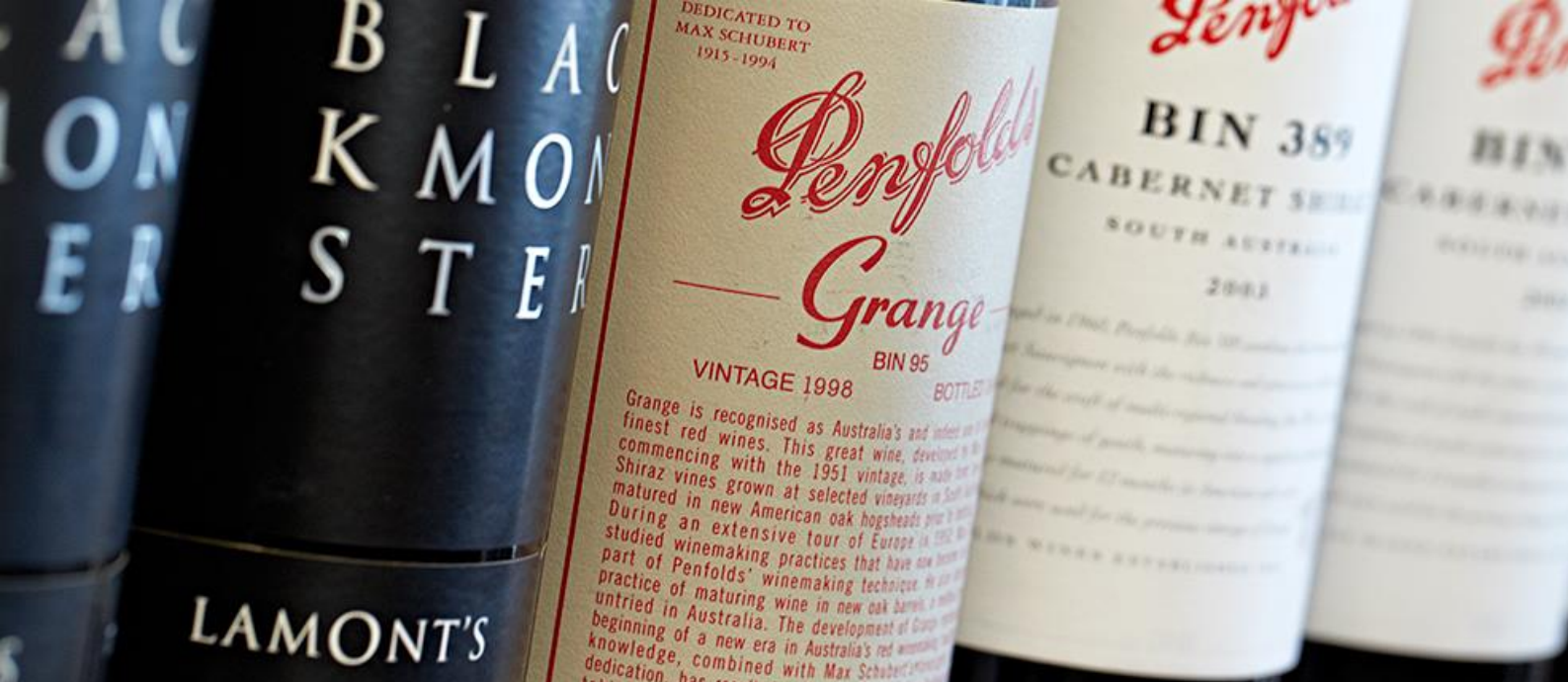

With most offering stunning ocean views, the rooms offer the perfect backdrop for pre-wedding photography. All rooms are fully self-contained, with modern facilities including large, flat screen televisions and Foxtel, Bluetooth soundbars, laundry facilities, outdoor showers and entertainers' balconies/courtyards with barbeque facilities.

Please note

- ▲ A 2 night minimum applies to all reservations.
- ▲ We recommend the maximum age for any children accommodated in the Beach Shacks is 14 years.
- ▲ A King split refers to a King sized bed which can be split into 2 x single beds as required.
- ▲ Our 2 bedroom Villas all feature a sofa bed in the downstairs bedroom, which can accommodate one additional guest. Extra charges apply.
- ▲ Please remember Smiths Beach Resort has a **strict NO party policy** in rooms.
- ▲ Smiths Beach Resort is **strictly non-smoking**. This includes external areas and balconies.
- ▲ Our rooms do not offer mini bar, however a custom mini bar can be supplied based on guest personal preferences. Additional charges apply.
- ▲ All accommodation at Smiths Beach Resort is fully self-contained, with kitchen and laundry facilities. Please note that for stays under 7 nights your room will not be serviced throughout your stay. For stays of 7 nights or more your room will be serviced mid-way through your stay. Additional room servicing is available at an additional charge by notifying reception. At least 24 hours' notice should be provided.

TERMS AND CONDITIONS

TENTATIVE BOOKINGS

Subject to agreement, tentative bookings for functions and accommodation may be held for a maximum period of 7 days. A non-refundable charge equivalent to the venue booking fee outlined on Page 3 is required to hold the date for function space. Bookings will be automatically cancelled if function or accommodation deposit is not received within this time.

BEACH WEDDING CEREMONY CONFIRMATION AND BOOKING FEE

A non-refundable fee of \$650 is required at time of booking your Beach Wedding ceremony. Permits from the Busselton Shire are included in the cost of the wedding ceremony charge. Permits cannot be applied until inside 12 months of the date of the ceremony. Any payment made to arrange the wedding ceremony is held pending permit approval being granted. If a permit is not granted, your payment will be refunded less an administration fee of \$100.

FUNCTION BOOKINGS

- ▲ A 50% deposit on all food and beverage packages is required at time of booking confirmation with the final balance due 28 days prior to event. These monies must be paid with a valid credit card held in the name of the booker. Alternatively a deposit can be EFT transferred and a card held for guarantee.
- ▲ Final guest numbers are required 21 days prior to your event date however cannot be less than 75% of originally quoted guests. Final invoicing will be charged at this number.
- ▲ Final food and beverage payment is required 21 days prior to the event - this number will be the minimum number invoiced. Final numbers may increase up to 48 hours prior to the event. The beverage balance and any further costs incurred require payment no later than 11am the morning after the event.
- ▲ Venue hire cancellations made from the time of confirmation to 22 days prior to the event will incur a cancellation fee equivalent to the venue hire fee. If cancelled within 21 days of the event date full payment of food, beverage and venue hire will be incurred.
- ▲ Lamont's Smiths Beach promotes the responsible service of alcohol and our staffs' discretion with service of alcohol during your function is final.
- ▲ Every effort will be made to maintain food and beverage prices as indicated, however prices may change without prior notice. Prices are inclusive of GST.
- ▲ A surcharge of 15% will apply on public holidays.
- ▲ Wedding ceremonies can be held at any time of the day. Receptions must conclude at the agreed scheduled time. Alcohol service concludes at 11.30 pm and the function venue must be vacated promptly by midnight. Failure to vacate the venue at the allocated time may result in an additional charge.
- ▲ **All noise must be kept to a minimum from 11pm to ensure the comfort of other resort guests, unless the resort accommodation is booked exclusively.** Appropriate noise levels are at the discretion of resort management.

VENUE HIRE, LOCATIONS AND HIRE COSTS

Venue hire and function bookings are subject to a minimum 2 nights' accommodation booked at Smiths Beach Resort over the duration of the function or event. Venue hire is inclusive of all set-up costs as outlined. Other items requested that are not owned by Lamont's Smiths Beach will be charged at hire, set-up and delivery costs. All table and room decorations are to be approved by Lamont's Smiths Beach.

CHILDREN

You are responsible for all persons under the age of 18 attending your function. Lamont's Smiths Beach will not be responsible or liable for any damage or injury suffered to, by or in connection with children, including if children leave the function venue or are not properly supervised by an adult.

ACCOMMODATION BOOKINGS

Individual Room Bookings

- ▲ A non-refundable deposit of 20% of the total room booking is required at time of booking.
- ▲ Final balance of payment is required within 28 days of arrival. Should balance of payment not be received at this time, the room/s may be released and deposit forfeited.

Group Policy (6 or more rooms)

When booking your wedding accommodation at Smiths Beach Resort, we offer two types of reservation options – a contracted 'Room Block' or an uncontracted discount 'Promotional Code'. A combination of the two is possible.

The Room Block

- ▲ This option allows you to book a 'block' of rooms for your guests at a contracted rate provided by our team. You are then financially liable for all rooms that form part of your reservation block (and therefore part of your contract) and all accommodation must be prepaid as per our Terms and Conditions. Given this, we would require you to advise us the following at time of contract – number of rooms, dates of stay and room types. Please note there are minimum room block requirements.

The Promotional Code

- ▲ With this option, we will provide you with a promotional code which provides yourself and your guests a discount off our best available website rates. This discount is valid only on bookings made direct via our website and is applied to the "Best Available Rate" at time of booking. Please be aware that this option does not guarantee room rates or room availability. Those guests that book via the promotional code do not form part of your contract and arrange payment individually at the time of booking.

Please note: Availability and room rates for contracted rooms are guaranteed at time of contract. The resort cannot guarantee availability and room rates for the Promotional Code option. The resort's fluctuating prices and the minimum length of stay restrictions will prevail.

General Resort Conditions

- ▲ Please remember Smiths Beach Resort has a **strict NO party policy** in rooms. To maintain a peaceful environment for all guests, we request that after 10pm only the guests registered to the room occupy the premise. Please ensure that all noise and balcony use ceases at 10pm. Any breach of these conditions may result in eviction without refund.
- ▲ No people other than the listed registered guests will be admitted into the property after 10pm. Guests may be required to produce I.D. for security reasons.
- ▲ Excessive loud music or noise in rooms that has potential to disturb other guests will not be tolerated under any circumstances.
- ▲ Please note that we do **not** allow the following bookings - In room parties, buck's nights, hen's nights, 18th birthday parties, 21st birthday parties, school leavers
- ▲ Damages of any kind other than normal wear and tear will be charged to the guest account
- ▲ Accommodation that is excessively dirty will be charged an additional cleaning fee to the guest account
- ▲ Smiths Beach Resort is **strictly non-smoking**. This includes external areas and balconies. A minimum charge of \$250 will be charged should a guest smoke in the accommodation including on balconies.

Should any of the above terms and conditions be violated the Management and Staff at Smiths Beach Resort reserves the right to evict all guests from the offending accommodation without refund of any payments and bonds that have been received.

Accommodation Payment Terms and Cancellations

Where notification of a cancellation is received more than 28 days prior to the arrival date, consideration may be given to allow a booking transfer to another date. Notice of cancellation received less than 28 days in advance of arrival date will result in the amount being non-transferable and will be forfeited.

We recommend an investment in holiday and travel insurance so that any unforeseen circumstances affecting your booking are covered.
